



299D Cat tracked Skidsteer Rental Agreement

This equipment lease agreement was entered on (mm/dd/yyyy) _____ between the lessor, RHUDE Group Ltd , and the lessee, _____, who, collectively, will be referred to as "the parties. The parties agree to the following:

1. Loss or Damage to UNIT

- a) Renter shall pay Rhude Group Ltd . for all loss, damage, and/or mechanical repairs to Cat 299D skidsteer and accessories, regardless of fault, resulting from abuse and/or misuse and/or negligence.
- b) The renter is responsible for the Cat 299D skidsteer from when it leaves the yard till it is returned to the yard during business hours.
- c) A cleaning fee will be applied if the Unit is returned uncleaned.
- d) The renter is required to notify us of any damage obtained during the time of the rental agreement.
- e) If any damages have occurred during the period of the rental agreement which the renter has not reported, (or is unaware of) when the return inspection gets completed, you will be notified of any damage we found during the return inspection. We will notify the renter before any charges get applied to the credit card we have on file.

2. Prohibited Use

The Cat 299D skidsteer of this contract shall not be used:

- a) By anyone whose ability to operate the tow vehicle is impaired by alcohol, drugs or fatigue.
- b) Outside of Alberta without written consent.
- c) In any contest.
- d) In violation of any law.

3. Loss of Use

The renter agrees to pay a sum equal to the regular daily rental rate of the Cat 299D skidsteer for each day the Skidsteer is unavailable for rent, regardless of fault, while any damage and/or mechanical repairs are made.

4. Reporting of Accidents and Theft

The renter shall report any accident or theft involving the Cat 299D Skidsteer to the police and shall complete a written report as soon as possible and in any event within 24 hours.

5. Payment

The renter shall pay all charges incurred in connection with the rental. Renter agrees that if the person or company indicated by renter to be responsible for payment fails to make payment, renter on demand agrees to pay all charges.

6. Tickets or Fines

The renter shall pay all fines plus 10% administration fee for all fines or fees associated with traffic and parking violations issued during the rental period.

7. Repossession

Rhude Group Ltd. may terminate this agreement and repossess the trailer at any time or place.

8. Personal Property

Rhude Group Ltd. is not responsible for loss or damage of any property left in, upon or carried in the Cat 299D Skidsteer.



9. Loads.

The renter agrees to pay for any and all damage and/or mechanical repairs resulting from the vehicle being overloaded or improperly loaded or resulting from an insecure load.

10. Tow Vehicle

a) Tow vehicles are not covered by Rhude Group. insurance.

b) If the Cat 299D Skidsteer referred to on this contract is damaged by a tow vehicle, the renter shall pay for all damage, loss of use, and towing.

c) All tow vehicles MUST HAVE the proper hitch and wiring required to tow the Cat 299D Skidsteer safely and they MUST be in good working order. This may include an electric brake controller if the trailer is equipped with brakes. Any problems or adjustments must be repaired, and the cost is the responsibility of the renter.

e) The renter is liable to ensure the Cat 299D Skidsteer is correctly hooked up for proper towing. If the Cat 299D skidsteer is incorrectly hooked up any damages done to the Cat 299D skidsteer or towing vehicle or any other property the renter is liable to cover all costs.

11. Delays and Breakdowns

Rhude Group is not responsible for loss of time, wages, inconvenience, loss of use of the vehicle, or other consequential damage or experience.

13. Licenses and Permits

Any and all additional licenses or permits required by provincial authorities are the responsibility of the renter.

14. Deposit

A booking and security deposit of \$2500.00 shall be required from the renter at the time of booking the Cat 299D Skidsteer. At the commencement of the lease, an inspection will be completed, and the security deposit will be refunded providing the Cat 299D skidsteer is returned by the time specified on this contract, clean, and in good condition.

15. Extending Rental or Late Fees

To extend a rental please call us 12 hours before your return date and the extra days will be charged to the card provided.

If a rental is not returned on the agreed-upon date you will be charged the day rate plus 50\$ for every day following.

SECTION TWO Waiver and Release

I, hereby (A) waive, release, and discharge from any and all liability for the death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter accrue to me, or my family and friends (B) hold harmless Rhude Group Ltd>. for any and all liabilities and claims made by other individuals or entities as a result of any of my actions or the actions of any associates, employees or reps.
